PRESIDENT'S MESSAGE

As I write this column, the immediate future of Hanover's children and teachers rests in the hands of our elected county supervisors. Will they pass the HCPS budget as presented or will they request additional tweaks that threaten to undermine the Hanover County Public Schools' branding so proudly enjoyed these past several decades. With less revenue to fund county services, the educational quality of our schools will eventually suffer. Loss of personnel, programs, and compensation are bound to take a toll as the county looks toward tight times again during the 2013-14 school year.

Hanover is not alone in facing the dilemma of budget angst. Governor McDonnell's declaration of "The Year of the Teacher" has called attention to the issues of educators throughout the Commonwealth, but the 2013 GA did not adequately address these issues. Legislation minus appropriate supporting funds seems to be a theme at all levels of government. This year VRTA Legislative Chair Bea Morris again kept us apprised of GA discussions, pending votes, and appropriate arguments to use when addressing our elected officials on educational issues. Those attending the HRSEA meeting on March 28th will hear how this and other recent legislation will effect teachers in our local classrooms.

While HRSEA continues to maintain close ties with HCPS, we are also actively reaching out to learn about county services and departments that offer opportunities for our membership. Our spring program will give you a taste of the volunteer programs that abound in Hanover County. As a retiree you can reap the rewards of using your talents in new endeavors by embracing the role of a volunteer. It's never too late to learn more about something new. I hope you attend this meeting to discover your "second" or even "third" career.

During our business meeting members will act on a recommendation from the HRSEA Executive Board to withdraw from VRTA District C and become a separate district under VRTA. The viability of being a part of District C has not in recent years served our unit well, with few members joining at the district level or attending district meetings. Be at the March meeting to partake in the discussion and cast your vote!

In closing, your officers and I thank you for your continued support and interest. We look forward to seeing you soon.



VA GA - 2013 Session Rpt.: SCHOOL GRADING LEGISLATION

From VRTA Legislative Chair Bea Morris as taken from The Washington Post, Metro Section, February 24, 2013:

Despite very vocal objections of educators because of oversimplification, the House and Senate approved a to "grade" schools on the following A-F scale:

- **A** fully accredited by the state, achieve at least a 25% advanced proficiency pass rate on SOL, meet all federal benchmarks for testing.
- **B** fully accredited but fall short of the advanced proficiency SOL pass rate.
- C has been accredited with a warning in one subject area.
- **D** accredited with warning in more than one subject area or fall short of target graduation rate.
- **F** denied accreditation or in the process of a government-mandated overhaul.

The state must also develop a new tool to measure how a school is improving before the first grades can be calculated. Lawmakers insisted on this provision so that the scale does not automatically disadvantage schools that serve higher-poverty students or more Englishlanguage learners. This grading system is scheduled to begin in the fall of 2014.

TREASURER'S REPORT

At the February 22, 2013 meeting of the HRSEA Executive Board, Treasurer Mary Waddy reported accounts totaling \$3,703.63. This figure reflects both general and scholarship accounts. The 2013-2014 HRSEA budget will be presented and adopted during the Business Meeting on March 28th.

The business session for voting members will be held on Tuesday morning. HRSEA member Thomas Folly will represent the unit as our voting delegate in the absence of your president at this meeting.

DISTRICT C - VRTA UPDATE

The District C level of the VRTA will hold its annual membership meeting on Thursday, May 9th at the Third Union Baptist Church on Walkerton Road in King William, VA. The meeting will run from 10 a.m. till noon with an optional luncheon available following the meeting. Members of the King William/King & Queen/West Point Unit will be hosts for this event. A flyer with additional information on the meeting and directions to it will be mailed out to all District C members in April.

During the business meeting the 2013 District C Scholarship winner will be announced, a budget will be adopted for 2013-14, and reports from the recent VRTA Delegate Meeting will be shared. Among those reports will be an update on the future of district levels within the VRTA and an update on unit membership in District C. Please plan to attend this meeting and hear firsthand about these issues.
