HRSEA BOARD MEETING RECAP

At the September 2, 2011 meeting of the HRSEA Executive Board the following topics were discussed and will be shared with the membership at the 2011 Fall Meeting:

- Presentation of the 2011-2012 budget based on 2010-2011 expenditures
- Proposed unit dues increase from \$8 to \$10 to ensure a balanced budget (vote required)
- Reduction of annual scholarship from \$1000 to \$500 (vote required)
- Proposed updates to the *HRSEA Bylaws and Standing Rules* as needed to reflect outcomes of voting on dues increase and reduction of scholarship
- Establishment of a dues cut-off date of December 31st of each year unit dues received after that date to be \$15
- Report on designing of a HRSEA logo for use with publications and letterhead
- · Report on using technology in communications and promotion, i.e. Email, website
- Establishment of a committee to develop a strategic action plan to focus HRSEA's vision and purposes

If there are additional topics and/or issues that you would like to see addressed by HRSEA, please bring your ideas to the table during the business session of the fall meeting.

TREASURER'S REPORT/MEMBERSHIP INFORMATION

Treasurer Mary Waddy reports that the HRSEA accounts total \$2,437.30 as of July 2011. This figure reflects the balance after all expenditures for the 2010-2011 year were paid. A complete report and proposed budget will be presented to members at the fall meeting.

VRTA DISTRICT C UPDATE

District C Scholarship

District C of the VRTA awarded two t\$1,000 scholarships this spring to two seniors graduating from schools within the district. Monies to fund these scholarships came from District C dues that have accrued interest over time. Mary Waddy, representing HRSEA on the District C Scholarship Committee, helped develop the criteria and design the application form for this scholarship.

The two awardees of the District C Scholarships <u>both</u> came from Hanover County high schools: **Kevin Michael Rackett, Atlee High School** and **Taylor Edwards, Lee-Davis High School**. Mr. Rackett is enrolled as a freshmen at the College of William and Mary. Ms. Edwards is beginning her college years at James Madison University. Both students were selected for their expressed desire to become educators, their extracurricular activities while in high school, academic honors/awards, community service, teacher endorsements, and financial need. HRSEA is proud of the achievements of these two future educators and the distinction they bring to our unit through their selection. Both were recognized for the award at their respective school's Senior Honor Award Night and each was presented a certificate to commemorate the scholarship received.

District C Transition Under Way

For the past several years Madelyn Cox (Chesterfield) and Louise Carlton (King William) have co-chaired District C and kept it a-float. At the recent District C Executive Board Meeting they, along with long-time District C Secretary Annie Mae Cowardin (HRSEA), resigned. Since new officers for the group will not be elected till spring 2012, an interim president and interim secretary will officially be appointed at the business meeting of the District C Meeting on October 20th. Cathy Daugherty (HRSEA) and Hazel Charity (Charles City/ New Kent) agreed to fill these positions.

To further update the workings of District C, several committees have been appointed to address needs. An ad hoc committee will revise the current *District C Bylaws and Standing Rules*. Larkin Phillips will represent HRSEA on this committee. A second committee will work on the District C 2011-2012 budget. Since between now and the end of June 2012 District C must address compliance with IRS regulations for non-profit organizations, having both an updated set of governing documents and a budget are minimal requirements for beginning this process.

WHY a Dues Increase and a HRSEA Scholarship Reduction: The Facts

Awarding an annual scholarship of \$1000 to a graduating senior at one of the four high schools in the Hanover County Public Schools System is a tradition of the HRSEA. Currently, the Executive Board follows the allocation of one half of the annual dues going to that scholarship. That means that \$4 out of the \$8 dues fee goes for the scholarship. With 125 members last year (fewer the previous year) the designated monies amounted to \$500. That means that in 2010-2011 to honor this scholarship, the HRSEA actually awarded the full unit dues payment of every member toward that scholarship, thus making the association reliant on paying its expenses from monies accrued from previous years when expenses were fewer and/or officers paid for them out of pocket.

With the balanced budget proposed for 2011-2012, changes need to be in place that will ensure we can support a scholarship and cover our meeting/membership expenses. The Executive Board proposes to raise dues from \$8 to \$10, \$4 of which will go toward a scholarship of \$500. The remaining \$6 will be designated to cover operating expenses, including meeting expenses, mailings/postage, and the directory publication.

Last year was a learning year for our organization. We kept close tabs on expenses so that a realistic budget could be developed this year and maintained in future years. We've learned a great deal. Now your Executive Board needs your support and your vote to strengthen our unit financially.
